- B. <u>License</u>. During the period of your Subscription (as defined in the Subscription Services section below) to the Disney+ Hotstar Platform, you will be granted a non-exclusive, non-transferable, non-sub-licensable, revocable, limited license to use the Disney+ Hotstar Platform and view the Content solely for your own personal, non-commercial purposes in accordance with the Terms of Use, and, except for the foregoing, no right, title or interest in the Disney+ Hotstar Platform or any Content will be deemed or construed to be transferred to you. - F. - I. You may encounter third party applications while using the Disney+ Hotstar Platform including, without limitation, websites, widgets, software, and/or services that interact with the Disney+ Hotstar Platform. Your use of these third-party applications shall be subject to such third-party terms of use or license terms. Disney shall not be liable for any representations or warranties or obligations made by such third-party applications to you under contract or law or otherwise.
- J. <u>Personal and Non-Commercial Use</u>. The Disney+ Hotstar Platform is provided to individuals for their personal, non-commercial use only. Companies, associations and other groups may not register for a Disney+ Hotstar Platform account or use the Disney+ Hotstar Platform.

2. **Provision of the Content**

- A. The Content will be made available to you through different modes, at the discretion of Disney, including video on demand for viewing at your discretion at a time chosen by you, through streaming and/or live streaming and/or temporary download for offline viewing.
- B. Disney+ Hotstar Content may be available for temporary download for offline viewing on certain Compatible Systems. Such temporary downloads may be limited to certain Compatible Systems, as may be permitted from time to time. You will not be permitted to download to an additional device once the maximum number of Compatible Systems has been reached. The length of time that certain temporary downloads remain available to you for offline viewing may change from time to time at Disney's discretion.

C. Disney will provide such amount and range of Content as determined by Disney at its sole discretion, for the duration of your Subscription and reserves the right to change, supplement, alter or remove any specific Content as it deems fit. - H. <u>Photo sensitivities</u>. - B. <u>Age Requirements</u>. To be able to subscribe to the Disney+ Hotstar Platform you must have reached the age of majority and be competent to contract under the applicable laws.
- C. IF YOU PERMIT ANYONE ELSE TO USE, VIEW OR ACCESS THE DISNEY+ HOTSTAR PLATFORM AND/OR THE CONTENT USING YOUR

ACCOUNT, YOU ACKNOWLEDGE THAT: (1) SOME CONTENT OFFERED ON THE DISNEY+ HOTSTAR PLATFORM MAY NOT BE SUITABLE FOR CHILDREN OR FOR SOME VIEWERS AND THEREFORE DISCRETION IS ADVISED; AND (2) THESE TERMS OF USE AS WELL AS ANY CONSENTS YOU MAY HAVE PROVIDED ALSO APPLIES TO THEIR ACCESS, USE, AND DISCLOSURE OF INFORMATION.

If the Dispute is not resolved by following the customer support process within sixty (60) days from raising the Dispute to the customer support then either you or Disney may submit the Dispute to the Singapore International Arbitration Centre ("SIAC") for final resolution by arbitration seated in Singapore in the English language in accordance with the arbitration rules of the SIAC in effect as of the date of arbitration, which rules are deemed to be incorporated by reference in this Section.
